Boat Ramp Signs

 Mark Patterson discussed the temporary signs now in place and proposed we have more prominent signs made to make boaters aware of what MPA does to protect Moose Pond. These signs will cost \$800 each and Mark is looking for volunteers to help pay for the signs.

Watershed Survey

- The survey teams have finished their work and around 180 opportunities were found where runoff into the lake could be prevented.
- People from the Cumberland Soil and Conservation District and LEA will review these findings and produce a report that will go to the Maine DEP who in turn will apply to the federal DEP. This will happen in 2011.
- Funds for supporting fixes (on a 50/50 basis) will be available in 2012.
- We will look into grant opportunities to support the fixes as well as appeal to the towns and homeowners to support the fixing

Fund Raiser Picnic

- The Picnic was not well attended due in part to the issue that we cancelled the original date and many were not available on the alternate date.
- We should consider alternatives.

Opportunities

2010 Fund Raiser Event?

 Several ideas were put forward: a boat parade and maybe end with a picnic or sell sandwiches or other items from the boats. Another idea was a kayak race. Other ideas are welcome – put your thinking cap on.

Grants

- One of our members is in the fund raising business and has provided the names of several organizations that might be amenable to a request.
- One idea for application would be to ask for help in the mitigation phase of the watershed survey.

Other Ideas?

Questions/Issues/Concerns of members

- The dangers of infestation are growing given the experience at the Songo Locks. A major breakthrough was accomplished with requiring mandatory inspections. The goal should be mandatory inspections everywhere and we need to work with LEA and the Congress of Lakes Organization to help make this become a reality. The majority of the taxes paid in Bridgton come from non-residents and Bridgton increasingly depends on the success of tourism. Without clean lakes the economy will be severely damaged and we need to develop a campaign to make this clear.
- o Another attempt will be made to get support from Bridgton.
- An appeal to the town of Demark for funding support will also be made.
